WE SUPERVISE

The commercial life of a vessel is often influenced by the cargoes carried, its trading pattern and the standard of technical management. However, the overriding factor that drives a vessel's longevity (and consequently its market value), is the **quality** – i.e. the design and construction of a vessel's build.

So, in addition to providing services to maintain the asset value during the commercial operations of a vessel, we recognize the importance of ensuring the best possible asset upon delivery.

At Fleet Management Limited, we lead an experienced and knowledgeable New Building Supervision Team. From the design phase to overseeing the construction and actual delivery of the vessel, we provide an end-to-end service for every need that can arise pre-delivery.

Our team consists of naval architects, structural engineers, electrical and control engineers, ex-chief engineers, NACE II certified paint inspectors and

ex-class surveyors who are heavily involved in each step of a newbuilding project. We are able to:

- assist with the design of the vessel to match your objectives;
- identify and vet suitable yards and sub-contractors;
- provide strategic advice relating to specifications and equipment (and their manufacturers) to be installed in the vessel;
- negotiate ship building contracts from both a technical and commercial perspective;

We are deeply committed to environmental sustainability. We truly believe that the demands placed on the environment can be met without reducing its capacity to allow all people to live well, now and in the future.

Our goal is to work towards a cleaner marine environment, by balancing our profitability and ambitions as a company with a dynamic environmental policy.

Safety doesn't happen by accident. It begins with understanding how accidents happen, and finding the cause. Most accidents occur not because safety policies and procedures are not in place but because some people lack an understanding of safety itself.

Fleet Management launched the award winning SafeR+ program in April 2010 to help seafarers understand the importance of communication, teamwork and risk assessment with the clear goal to reduce crew injuries by 50%. Motivating every seafarer to be accountable for doing things better today than yesterday, we introduced

workshops, daily onboard team talks and training sessions to highlight safe/unsafe behavior on board vessels.

Since its launch the program has been upgraded twice (in 2012 and 2014) and has contributed to a reduction of incidents by 76% and increase in near miss reports by 550%. Furthermore, the company's bulk carriers are now being operated at the same levels of safety as tankers: one company with one safety culture throughout.



Zero incident, zero spill, and zero-tolerance

In accordance with all applicable quality, safety and environmental standards, we fully comply with requirements established under International, Flag State, Port State and Coastal State Laws, and most particularly the International Convention for the Prevention of Pollution from Ships (MARPOL). We believe that the first line of defense against pollution is to avoid accidents from occurring.

Our aim is to achieve zero incidents, zero spills, and we implement a zero-tolerance approach to any non-compliance and violations with this policy and will extend full cooperation to authorities in the unlikely event of an occurrence.
